# 2025 CWCA Pool Rules

#### NEW POOL POLICIES

There is a permanent ban on the following items at the Canterbury Woods community pool:

- Large inflatables
- Multi-person inflatables
- Any medium to large float that obstructs the view of the bottom of the pool

The following items will be allowed:

- Noodles
- Small kickboards
- Individual child-sized floaties
- Individual inner tubes

The following policies will be in place:

- If an object in the pool is not in use, remove it from the pool.
- Any floats, toys, or other item(s) left behind when the pool is closed for the evening will be removed and disposed of.

Any person at the Canterbury Woods community pool found not in compliance with the aforementioned policies will be asked to leave the pool immediately. Repeat offenders may have pool privileges revoked.

#### **CONTINUED POOL POLICIES**

- NO GLASS CONTAINERS OF ANY KIND
- No pets allowed
- NO SMOKING OR VAPING
- No alcoholic beverages
- No food/drinks allowed within 10 feet of the pool
- Children under 12 years of age must be accompanied by an adult
- No chewing gum in the pool (a drowning risk if lodged in the throat)
- · No skateboards, rollerblades, bicycles or other vehicles
- No diving, running, horseplay, excessive noise levels, abusive language or vandalism of pool property
- No playing with drain, skimmers or pool equipment
- IPODS, CD players and personal radios are permitted if used with earphones
- Appropriate Attire. This is a family pool modesty in attire is expected
- No outside furniture; swings; hammocks; etc.
- No Large inflatables; multi-person inflatables; any medium to large float that obstructs the view of the bottom of the pool

### HEALTH AND SANITATION:

- Pool privileges will be refused to persons having colds, coughs, inflamed eyes, infections, open sores, poison ivy or wearing bandages
- Swimmers shall shower before entering pool
- No spitting or other unhygienic behaviors
- Children not toilet trained MUST wear swim diapers. Parents will be fined \$250 should the pool require a fecal decontamination by our maintenance company
- Each resident is responsible for picking up his/her own trash

### **SAFETY REGULATIONS:**

- Children under 12 years of age must be accompanied by an adult
- The gate to the pool area is to remain closed and locked at all times, and is not to be propped open or otherwise left unsecured
- Do not open the pool gate to let in unsupervised children or guests
- Pool furniture must be kept at least 4' from the pool edge (DHEC regulation)
- Thunder everyone out of the pool for 15 minutes from the last time thunder was heard
- Lightening everyone out of the pool for 30 minutes from the last time lightening was

#### seen

• Heavy rain — pool must be emptied of swimmers if the bottom of the pool cannot be seen clearly during a rain storm. Swimmers may re-enter the pool only when the rain abates and the bottom can be seen

#### **GUEST POLICIES:**

- The residents must be present with their guest(s) in the pool area at all times
- Adult members have the responsibility to enforce rules to ensure the safety of all patrons and are legally responsible for damages caused by family or guests
- Parents should be aware of the use of guest privileges by their children. Please do not misuse or abuse these privileges

## Any person deliberately damaging pool furniture or pool structures or trespassing after hours will be automatically suspended for an indefinite period and/or criminally prosecuted.
